2023 Commission Seat Opportunities

The Fresno-Kings-Madera Regional Health Authority Commission was established under the Joint Exercise of Powers Agreement between the Counties of Fresno, Kings, and Madera for the Joint Provision of Medi-Cal Managed Care and Other Health Services Programs. The purpose of the Commission is to provide Medi-Cal managed care systems or other health care systems to serve eligible residents of the counties of Fresno, Kings, and Madera and to negotiate and enter into contracts. The Commission may also enter into contracts for the provision of health care services to individuals that are entitled to coverage under other publicly supported programs, those employed by public agencies or private businesses, and uninsured or indigent individuals.

The following Commission seats are up for reappointment in 2023:

- One (1) seat is up for reappointment in *March* 2023:
 - Kings County: One (1) position *appointed by the Board of Supervisors of Kings County* who is representative of the interests of health care consumers, providers of pharmacy services or other health care services, or other person meeting the qualifications per Bylaws.
- One (1) seat is up for reappointment in *April* 2023:
 - <u>Kings County</u>: One (1) position <u>appointed by the FKM Regional Health Authority Commission</u> who are representatives of the interests of physician providers of Medi-Cal covered health care services, health care consumers, community representatives or community clinics.
- One (1) seat is up for reappointment in <u>May</u> 2023:
 - Fresno County: One (1) position *appointed by the Board of Supervisors of Fresno County* who is representative of the interests of health care consumers, providers of pharmacy services or other health care services, or other person meeting the qualifications per Bylaws.
- One (1) seat is up for reappointment in <u>September</u> 2023:
 - <u>Madera County:</u> One (1) position <u>appointed by the Board of Supervisors of Madera County</u> who is representative of the interests of health care consumers, providers of pharmacy services or other health care services, or other person meeting the qualifications per Bylaws.

Membership Composition:

Not less than seventeen (17) members shall represent the following constituencies:

- Six (6) appointed by Board of Supervisors of Fresno County, plus alternates
- > Three (3) appointed by Board of Supervisors of Kings County, plus alternates
- > Three (3) appointed by Board of Supervisors of Madera County, plus alternates
- > Three (3) appointed by the Commission, one each from Fresno, Kings and Madera Counties
- > One (1) from Children's Hospital of Central California
- > One (1) from Community Regional Medical Center

The purpose of this notice is to give any individual the opportunity to apply as well as any special interest group the opportunity to submit names of individuals to be considered for appointment.
