Building Stronger Communities Together: CalViva Health Supports Habitat for Humanity in Firebaugh

CalViva Health is proud to support Habitat for Humanity Greater Fresno Area and its mission to expand affordable homeownership across rural Fresno County. In April, CalViva Health joined community leaders and partners at the groundbreaking ceremony for the San Joaquin Villas development in Firebaugh, a project aimed at revitalizing a long-dormant subdivision with seven new homes for local families.

Thanks in part to CalViva Health’s funding, Habitat for Humanity was able to purchase and begin constructing fencing around the entire development. This perimeter fence represents more than just a physical boundary; it’s a symbol of safety, stability and a long-term investment in the neighborhood's well-being.

“CalViva Health is deeply committed to supporting the health of the whole community,” said Jeffrey Nkansah, CEO of CalViva Health. “When families have access to safe, stable and affordable housing, they are better positioned to thrive in every aspect of life.”

This partnership builds on CalViva Health’s continued support for Habitat for Humanity’s “Acts of Kindness” program, which has provided minor repairs and home improvement services to more than 90 low-income households across the region.

Health Net Grant Helps Modesto Gospel Mission Achieve Success - One Person at a Time

Health Net recently granted the Modesto Gospel Mission in Modesto, California, nearly \$314,000 as part of an overall CalAIM Incentive Payment Program throughout California. Health Net joined other Medi-Cal managed care plans in giving more than \$1 million to the project. The funding is part of a larger effort to expand the Department of Health Care Services Enhanced Care Management and Community Supports in order to:

- Bridge gaps in both physical and behavioral health care service
- Reduce health disparities
- Promote health equity
- Improve quality and more

For the Modesto Gospel Mission, the money will go a long way to bring much needed upgrades to the center that include:

- Hiring and training more staff
- Supplies to support Community Services growth
- Golf carts to transport members to care services
- New furniture, laundry carts and landscaping supplies

Funds will also pay for utilities, insurance, pest control and more.

More than \$9 Million in Initiatives to Expand and Strengthen California's Physician Workforce

Health Net and the Centene Foundation gave more than \$9 million to help more people become doctors in California. These grants remove roadblocks to medical school and help support current doctors.

The grants include:

- **Physicians for a Healthy California – \$3 million** to build a program that helps kids—starting in pre-K—dream of and prepare for a career as a doctor. By supporting students in early childhood, this project helps to expand the future doctor workforce. And it can help ensure California's growing residents have access to the care they need.
- **Charles R. Drew University of Medicine and Science – \$5 million** to provide full-tuition scholarships, financial support for medical residents, and other resources to recruit and retain future doctors. This will ensure students receive the training and support they need to deliver high-quality care.
- **National Hispanic Health Foundation – \$1.08 million** to enhance the leadership capabilities of Hispanic doctors and their understanding of current health policies through a new career development program. The program provides crucial insights into patient needs, systemic challenges and prospects for improvement.



Doctors play a pivotal role in providing informed and inclusive care. These investments in California's physician workforce will help to shape the future of the state's health care landscape for years to come.

MLK Community Medical Group Adds More Providers Thanks to \$3.5 Million Grant

Funds help address a shortage of doctors and other clinical staff to deliver Angelenos vital health care services for the next three years

Health Net gave **\$3.5 million** to MLK Community Medical Group to help hire more doctors and nurses in Los Angeles through 2027.

The money helps bring on:

- Two primary care doctors
- One OB/GYN
- One bilingual psychologist
- Two nurse midwives

Overall, these hires help ensure more people in underserved communities can get timely care like routine checkups, prenatal services and mental health support.
